## **SPEAKERS**

### **Mark Haffey**

Mark Haffey, BSN, MS, CRNA, received his anesthesia training at the Wake Forest Baptist Medical Center Nurse Anesthesia Program including a Master of Science in Nursing from the University of North Carolina-Greensboro. His Bachelor of Science in Nursing is from Kansas University as well as a Bachelor of Arts in Biology from MidAmerica Nazarene University.

Mark is a Certified Registered Nurse Anesthetist at Avera McKennan Hospital and University Health Center in Sioux Falls, SD. Currently serving in his 23rd year as a CRNA, his clinical expertise includes Otolaryngology, Neuro, Orthopedics, and providing Rural Anesthesia.

Mark has served as Director of Region 4 and Vice President on the AANA Board of Directors and has served in many leadership roles at both the state and national level. He was also inducted as a Nurse Anesthesiology Fellow of the AANA.



## Remimazolam: A New Short Acting Benzodiazepine

This session will provide a breakdown of Remimazolam, a brand new anesthestic agent specifically designed for cases lasting 30 minutes or less. It will include the pharmacodynamics and pharmacokinetics of Remimazolam, identifying optimal patients and ideal procedures for its use, and understanding both on-label and off-label uses.

### TIVA: Not Just Designer Anesthesia

This sesssion will provide an in-depth breakdown of Total IntraVenous Anesthesia (TIVA), including pharmacologic agents for amnesia, analgesia, anti-inflammatory, and paralytics. It will provide education on the advantages and disadvantages of using TIVA, identify Cases appropriate for TIVA, and identify types of patients for which TIVA is designed.



### **Shannon Hoy**

Dr. Shannon Hoy, DNP, CRNA, is the chief CRNA at Children's Hospital and Medical Center in Omaha, Nebraska. She is a member of the Professional Practice Evaluation Committee, the Physicians and Providers Advisory Council as well as the Pediatric Intensive Care Interdisciplinary Committee. She completed her Neonatal Nurse Practitioner program at the University of Nebraska Medical Center, her CRNA program at Clarkson College in Omaha Nebraska and her Doctorate at UMass Amherst. Dr. Hoy is also has been extensively involved in philanthropy in her community, serving on multiple boards over the years including Junior League of Omaha, Child Saving Institute as well as the Aksarben Foundation.

#### Living on the Edge: Anesthesia at the Pediatric Ambulatory Surgery Center

This session will provide a review of current ambulatory center guidelines and recommendations, facilitate discussion on difficult situations ambulatory anesthesia providers face, and identify professional and safe resolutions. This session will also provide information on treating patients with chronic illness, obesity/obstructive sleep apnea, upper respiratory infections, and former premature infants. Dr. hot will also review current outpatient discharge guidelines.

Suzie Newell Suziof e Observation de Constitution de Constitut

Suzie Newell, DNP, CRNA, FAANA, is a nurse anesthesiologist with 19 years of experience specializing in obstetric anesthesia, including as Chief of Obstetric Anesthesia for Capital Anesthesia (Sound Anesthesia). She is an established lecturer, teacher, and author whose experience includes work in anesthesiology, on advocacy and policy, obstetric anesthesiology, and mental health. Her work in obstetrics in the heart of the opioid crisis includes running the national online group Recovery Path for Mothers and Others.

#### **Obstetric Anesthesia Curent Review**

Obstetric anesthesia as a specialty is often overlooked in our practices. Research around the issues we face in labor and delivery is ongoing. This lecture reviews current issues in obstetric anesthesia including thrombocytopenia, intrathecal opioid dosing, managing uterine tonics, and other current issues.

## Flip The Script: Creating a Safe and Effective CRNA Full Scope Practice in Obstetrics Through Smart Leadership

The dynamic of flipping a group from physician to CRNA can be wrought with power dynamics, ego, ignorance, and misguided leadership. This lecture covers various aspects of changing obstetric anesthesia departments from an all-physician group to an all CRNA group.

#### Hemorrhage in OB and Other Emergencies

BLEEDING IN OB! This lecture reviews the latest theories in obstetric hemorrhage including scenarios that lead to bleeding.

## What's Wrong With Her? Neuroscience, Disparities, and De-stigmatizing Mental Health in Obstetrics

The mental health patient in obstetrics faces the stress of being at the hospital with the addition of pain. She often comes with a dearth of coping mechanisms. This lecture seeks to clarify the science behind some common mental health conditions and identify how the provider can help the patient improve her experience on the labor deck.

Dr. Shannon Pecka, PhD, CRNA, is a Professor and the Assistant Program Director in the School of Nurse Anesthesia at Bryan College of Health Sciences where she has taught didactic anesthesia courses since 2010, primarily in Advanced Principles of Nurse Anesthesia. Dr. Pecka has clinical experience in anesthesia, including rural anesthesia practice, moderate-sized private practice anesthesia groups, and large academic settings. Her prior registered nursing experience includes intensive care settings of Surgical ICU, Neuro ICU, and General Medical/Surgical ICU. Dr. Pecka served on the NANA Board of Directors, including Secretary/Treasurer, has authored/co-authored publications for the AANA Journal and Midwest Nursing Research Society, and currently serves on the editorial board of the International Student Journal of Nurse Anesthesia.

# Heart Failure With Preserved Ejection Fraction (HFPEF): Pathophysiology, Echocardiogram Implications, and Management

This session will explore the implications of heart failure with preserved ejection fraction (HFPEF). Emphasis will be placed on the pathophysiologic development and how this impacts echocardiogram findings. Management strategies will also be explored.
